At the time of inspection, I observed a frac pad where Crestone Peak was conducting remote frac operations on the Woolley Becky Sosa location and the Crestone Peak Hilltop locations. I reviewed location records, which did not show any abnormal fracking conditions at the time of the complaints. I also reviewed Environmental Noise Control Inc. continuous sound study information which also did not show any exceedance of COGCC rules at the times of the complaints.</p> <p>Crestone Peak installed additional sound mitigation walls to the south and the west of location at the time of this inspection. Photos were attached to the inspection.</p> <p>A previous sound study taken at location approx. 350' to the south of the noise source per COGCC guidance did not show any violation of COGCC rules. Due to high winds in the area at the time of the inspection no sound studies were performed.</p> <p>All information reviewed and site inspection information were submitted to the complaint specialist for further review.</p> <p>No violations of COGCC rules were observed at the time of the inspection.</p>
