## COMMENTS:

Black Hills is requesting an extension to the currently approved Form 15 pit located on the HDU 9-11 well pad (Facility ID 432419, Doc# 400356093). The request is to extend the pit for a period of six (6) months past the expiration date of March 13, 2017 to a new expiration date of September 14, 2017. Black Hills is requesting to extend this Form 15 permit to allow for fresh water holding to assist with frac operations being conducted on the HDU 7-23 well pad this summer. Upon the completion of frac operations (est. August 2017), a Form 27 Site Investigation and Remediation Work Plan (Form 27) will be submitted to request a Remediation # and begin initial pit closure activities. By extending the Form 15 permit and allowing Black Hills to use the pits as fresh water holding, traffic & dust will be drastically reduced, as well as minimizel impacts to surrounding environment.
