Kris,

Due to a mistake during final reclamation work last year, the State of Colorado 2 location was reclaimed. There were 2 open pits on this location that had been previously approved to be sampled, facility 100403 and 100404.

As per our discussion over the phone, Wexpro Company will dig up the pits, most likely with a backhoe, and fence them off. We will then sample them, and have them tested per Table 910-1. After analysis has been approved by the COGCC (analysis will be submitted via Form 27), we will then backfill the pits again and continue with final reclamation of the well pad.

BLM has also been made aware of the situation on this well pad and will be sent soil analysis as well.

Just to be clear, would you like 72 hour notification for the soil sampling only, or would you like to be present and notified for the digging of the pits as well?
