Dear Director Lepore:

We would like to respectfully request a variance for an extension of five years to comply with Rule 1003.b. and 1003.e. as outlined in the Notice to Operators dated January 5, 2017. We have received written consent from the surface owner to delay commencement of interim reclamation for a period five years.

Under current market prices, it is not economic to drill or produce any new wells on this location. We hope to resume activity when the market recovers. In an effort to avoid the cost of performing interim reclamation, then subsequently rebuilding the pad to accommodate activity, we would like to delay the commencement of interim reclamation.

Over the next five years we will be awaiting improved commodity prices to drill the well currently permitted for this location. Storm water and noxious weed control will continue to be monitored.

This location is currently in compliance with Rule 1002.f., Rule 1003.a., and Rule 1003.f. Attached to the Form 4 you will find a spreadsheet outlining the estimated cost for a third-party contractor to perform interim reclamation.

Lastly, you will find an executed COGCC Operator Rule 1003 Tolling Agreement, per the NTO.


