Jodi,
It looks like only the State 1-15 gas was analyzed and the date was back in 2012. We would like a new analysis when flaring begins (including H2S). How about if I change the wording of COA #5 to this:

5) Within 30 days of commencement of flaring: collect a new gas sample for laboratory analysis including hydrogen sulfide and submit a new Form 4 with the laboratory results. Analysis attachments to the new Form 4 shall be a PDF copy of the laboratory data sheet and an Electronic Data Deliverable (EDD) prepared by the laboratory in the format specified on COGCC's website, located in Help => Environmental => COGCC EDD Information.

Thanks Jodi,

The Conditions of Approval on the sundries are:

1) Comply with all requirements of Rule 912, including monthly reporting of flared volumes (on Form 7) and notifications to local emergency dispatch or the local government designee.

2) Submit annual updates (requests to flare) to COGCC on Form 4s (Sundry Notices), including all information specified in COGCC's "Notice to Operators, Rule 912 Venting or Flaring Produced Natural Gas - Statewide."

3) Comply with any Colorado Department of Public Health and Environment, Air Pollution Control Division rules or requirements for all atmospheric discharges.

4) An enclosed flare shall be used, unless an open flare is specifically allowed by CDPHE's Regulation 7.

5) Within 30 days of approval of this form, submit an Electronic Data Deliverable (EDD), prepared by the laboratory that performed the gas analysis attached to this form. The EDD shall be submitted with a new Form 4, in the format specified on COGCC's website, located in Help => Environmental => COGCC EDD Information.

Let me know if you have trouble getting your lab to provide #5. We are trying to get the data submitted electronically, it is an ongoing process.

Craig,

Per your request, we are attaching the detailed pricing information for gathering and processing gas and generating electricity from the natural gas. We have not been able to confirm a market for generated electricity in the area. But our visit to the field resulted in observing the nearest 3-phase power lines are 2 miles from the Breeze 11-8 well.

Thank you for your consideration and please contact me if you require anything further. The CDPHE will not grandfather the equipment on location, so they are requiring enclosed flares. Upon COGCC approval, ECDs would be installed and permitted with CDPHE in due course. We are still hoping to have your approval and the equipment installed before the snow flies.






