General Comment:

Site visit to assess management of potentially contaminated drill cuttings. Met with Ursa company man, Nate Gill. Cuttings are stockpiled on SW corner of pad. Cuttings not bermed but pad is bermed. Cuttings are dry and no indication of sediment runoff. No signs of petroleum contamination. One area of black material results from drilling through Cameo coal formation. Mr. Gill stated that no oil-based mud is being used. Cuttings sampling/analysis and subsequent management is subcontracted to HRL Compliance (Kris Rowe). If samples are < Table 910-1 concentrations, cuttings will be recycled for beneficial re-use. Otherwise material will be remediated or disposed per COGCC rules.
