Rigged up to wash down and retry. 9:00 washing down with washover pipe. 10:00 ran impression block. Looks like no more fish in hole. Measured flow out of 2" with garbage bag about 40 gal in 20 min. 12:45 reaming out with 6 3/4" drill bit. Shut down 13:30 to 14:00 due to power swivel issue. 14:45 remaining at 33'. 15:45 drilling formation at 60', slight rate increase. 17:00 drilled to TD from ground surface of 90.9'. 17:30 off location.
