#### Procedure:

1. Run gyro survey.
2. MIRU pulling unit. Pull 2 3/8" tubing.
3. RU wireline company.
4. TIH with CIBP. Set BP at 7220'. Top with 2 sxs 15.8#/gal CI G cement.
5. TIH with CIBP. Set BP at 6890'. Top with 2 sxs 15.8#/gal CL G Cement.
6. TIH with CIBP. Set BP at 4607'. Top with 2 sxs 15.8#/gal CI G cement.
7. TIH with casing cutter. Cut 4 1/2" casing at 608'. Pull cut casing.
8. TIH with tubing to 702'. RU cementing company. Mix and pump 245 sxs 15.8#/gal CI G cement down tubing. Cement should circulate to surface.
9. Cut surface casing 6' below ground level and weld on cap.
