Comment: On location to observe well after placement of 25 gallons of WellLock Resin on 6/14/2017. Tagged resin top at 8'1" below top of casing. Top was at 10' on 6/14 before placement. About 20 gallons of resin went into voids and 5 gallons to raise the top to 8'1". Measured methane (LEL) at 22% in casing. Placed 5 gallons of water in casing at 9:30. Gas bubbling through the water was observed. Bubbling was intermittent and at times the water was still.

Corrective Action: **Plug and abandon.** Date: 06/23/2017
