There is a pipe riser at the north side of the location. The Hosmer 4-9 well was plugged and abandoned on 7/15/2015 and all equipment should have been removed by 10/15/2015. There are areas of disturbance that have not been reclaimed and there are noxious weeds at the location. See Attached Photos**

Corrective Action:	Comply with the 1004 Final Reclamation Regulations. Control noxious weed growth. Remove all equipment, Regrade and decompact soils by cross ripping to a minimum depth of 18 inches. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed.	CostaR	06/16/2017
