OPERATOR COMMENTS AND SUBMITTAL

Comments Well is part of the 2-well Y34-15 Pad (Doc #401286221), consisting of the proposed Shufly State Y34-744 (Doc #401286219) & Shufly State Y34-754 – Ref. Well (Doc #401286220). The wells will produce to the proposed Y34-16 Multi (Doc #401286218). Noble Energy shall isolate both the Fox Hills and Upper Pierre Aquifers with surface casing from hydrocarbon bearing zones and exposure to oil based drilling fluid. Noble Energy also agrees to not expose the UPAq to oil based mud.

The Bison Ridge wells listed on the attached anti-collision have not yet been submitted. The wellbore distances cannot be considered in nearest well figures.

Nearest well (from the Shufly State Y34-744 anti-collision) is the proposed Shufly State Y34-744 638’.

Nearest outside operated well is the Centennial-operated (PA Status) Barnes 2-34 (API: 123-10396) 1222’.

Wellbore to wellbore distances populated from attached anti-collision report unless otherwise indicated.

Waiver language is included in attached SUA (Page 4, Section 6.A).

Although Noble is permitting the BHL for the well to be 2500’ FSL of Section 22, the ability to perforate will be physically constrained by the float collar which will be located no less than 2460’ FSL of Section 22. Noble will not perforate the wellbore within the 150 foot setback area of the spacing unit.

1	General Housekeeping	Housekeeping will consist of neat and orderly storage of materials and fluids. Wastes will be temporarily stored in sealed containers and regularly collected and disposed of at offsite, suitable facilities. If spills occur prompt cleanup is required to minimize any commingling of waste materials with stormwater runoff. Routine maintenance will be limited to fueling and lubrication of equipment. Drip pans will be used during routine fueling and maintenance to contain spills or leaks. Any waste product from maintenance will be containerized and transported offsite for disposal or recycling. There will be no major equipment overhauls conducted onsite. Equipment will be transported offsite for major overhauls. Cleanup of trash and discarded materials will be conducted at the end of each work day. Cleanup will consist of patrolling the roadway, access areas, and other work areas to pickup trash, scrap debris, other discarded materials, and any contaminated soil. These materials will be disposed of properly.
2	Storm Water/Erosion Control	Stormwater management plans (SWMP) are in place to address construction, drilling and operations associated with Oil & Gas development throughout the state of Colorado in accordance with Colorado Department of Public Health and Environment (CDPHE) General Permit No. COR- 038637. BMP's will be constructed around the perimeter of the site prior to, or at the beginning of construction. BMP's used will vary according to the location, and will remain in place and maintained until the pad reaches final reclamation.
3	Material Handling and Spill Prevention	Spill Prevention Control and Countermeasures (SPCC) plans are in place to address any possible spill associated with Oil & Gas operations throughout the state of Colorado in accordance with CFR 112.
4	Drilling/Completion Operations	When NOT Using an Existing Well's Log as an Exception: One of the first wells drilled on the pad will be logged with open hole Resistivity Log and Gamma Ray Log from the kick-off point into the surface casing. All wells on the pad will have a cement bond log with gamma-ray run on production casing (or on intermediate casing if production liner is run) into the surface casing. The horizontal portion of every well will be logged with a measured-while-drilling gamma-ray log. The Form 5, Completion Report, for each well on the pad will list all logs run and have those logs attached. The Form 5 for a well without open-hole logs shall clearly state "No open-hole logs were run" and shall clearly identify (by API#, well name & number) the well in which open hole logs were run.
5	Drilling/Completion Operations	If a skid is performed for the subject well, then the only required BOPE tests are for the BOPE connection bonnet seal breaks, as long as a full BOPE test was performed at the beginning of the pad, and as long as all necessary BOPE tests are completed at least every 30 days during the pad operations.
