





WELL LOCATION CERTIFICATE

In accordance with a request from Jay Knutson of Crestone Peak Resources, Washburn Land Surveying, LLC has determined the location of the **Sam 3B-25H-M166** well site to be SHL: 1403' FSL and 311' FWL, (TPZ: 2425' FSL and 480' FWL), (BHL: 2425' FSL and 460' FEL), as measured at ninety (90) degrees from the section lines of Section 25 Township 1 North, Range 66 West of the 6th Principal Meridian, Weld County Colorado.
