Dear Mr. Lepore:

SandRidge Exploration & Production, LLC (SandRidge) respectfully requests that the Director grant an exception location to Colorado Oil and Gas Conservation Commission (COGCC) Rule 603.a.(2), for the above referenced well. The planned well location was agreed upon by SandRidge, the private surface owner and the offset surface owner through multiple conversations and meetings due to topography, location limitations, wildlife conservation, and to maximize current and future land use possibilities by the surface owner.

Per COGCC Rule 603.a.(2), a well shall be located not less than one hundred fifty (150) feet from a surface property line. The above referenced well is less than the require 150 foot setback from the surface property line. For various reasons, as stated above, SandRidge could not comply with COGCC Rule 603.a.(2).

The well location is in compliance with all other COGCC Rules and Regulations. The Bureau of Land Management (BLM) is the offset surface owner. BLM, in concurrence with the surface owner has requested the wells be placed in the proposed locations.

SandRidge requests the Director approve the proposed exception locations for the above referenced well. The surface owner acknowledges and agrees with the staked surface location of the wells and the offset to both the property on which the wells will be placed as well as the adjacent property. Please see the enclosed waivers.
