- Production Csg: 4.5" – 10.5# - Set @ 7157' w/ 175 sks
- CBL Production TOC @ 6250'

Following continuing WBI preparation...

- 1) Spear and unland 4.5" production casing. NU cement flange.
- 2) TIH 1 1/4" CS Hydril to 5170' in production casing annular space.
- 3) Circulate as needed.
- 4) RU cementers. Mix and pump 410 sx 13.5# premium lite cement for annular coverage from 5020' to 3595'.
- 5) TOO H to 600'. Mix and pump 230 sx 15.8# class G cmt for annular coverage from 600' to surface. Top off as necessary for cement to surface.
- 6) ND cement flange and re-land 4.5" production casing.
- 7) Run CBL from 5250' to surface to confirm adequate cement coverage.
- 8) Continue with originally planned WBI prep.
