This is a final reclamation inspection.

Document 579634 describes plugging the well on September 8, 1991.

Document 579636 provides COGCC permission to release the location based on surface owner approval. Describes the pit being reduced by half for livestock watering. Area adjacent to well pad and well is being used for what appears to be equipment storage by the surface owner. It appears this area was developed after the well pad was reclaimed (Google Earth 2017 aerial imagery). See attached photos.
