Comment: **There is gravel that remains at the former tank battery site. The soils appear to be compacted along the access road, location, and tank battery site. The desirable vegetation has not established and there is predominately undesirable weed growth. See Attached Photos**

Comply with the 1004 Reclamation Rules. Remove all gravel and debris that remains. Decompress soils by cross ripping to a minimum depth of 18 inches. Stabilize the disturbed soils with a certified weed free mulch or equivalent method until vegetation establishes.
