Comment:

Well location appears to meet reclamation standards. However, a significant portion of the access road has not been reclaimed. Based on aerial imagery, it appears the access road was re-routed and constructed around 2002-2004, approximately 10 years after the well had already been operating. If the Operator wants to leave the access road "as is", then a 502.b. variance needs to be submitted. It is unclear whether the surface owner is using the access road or whether it was a failed reclamation attempt. Please see the attached inspection photo Document #682402307.
