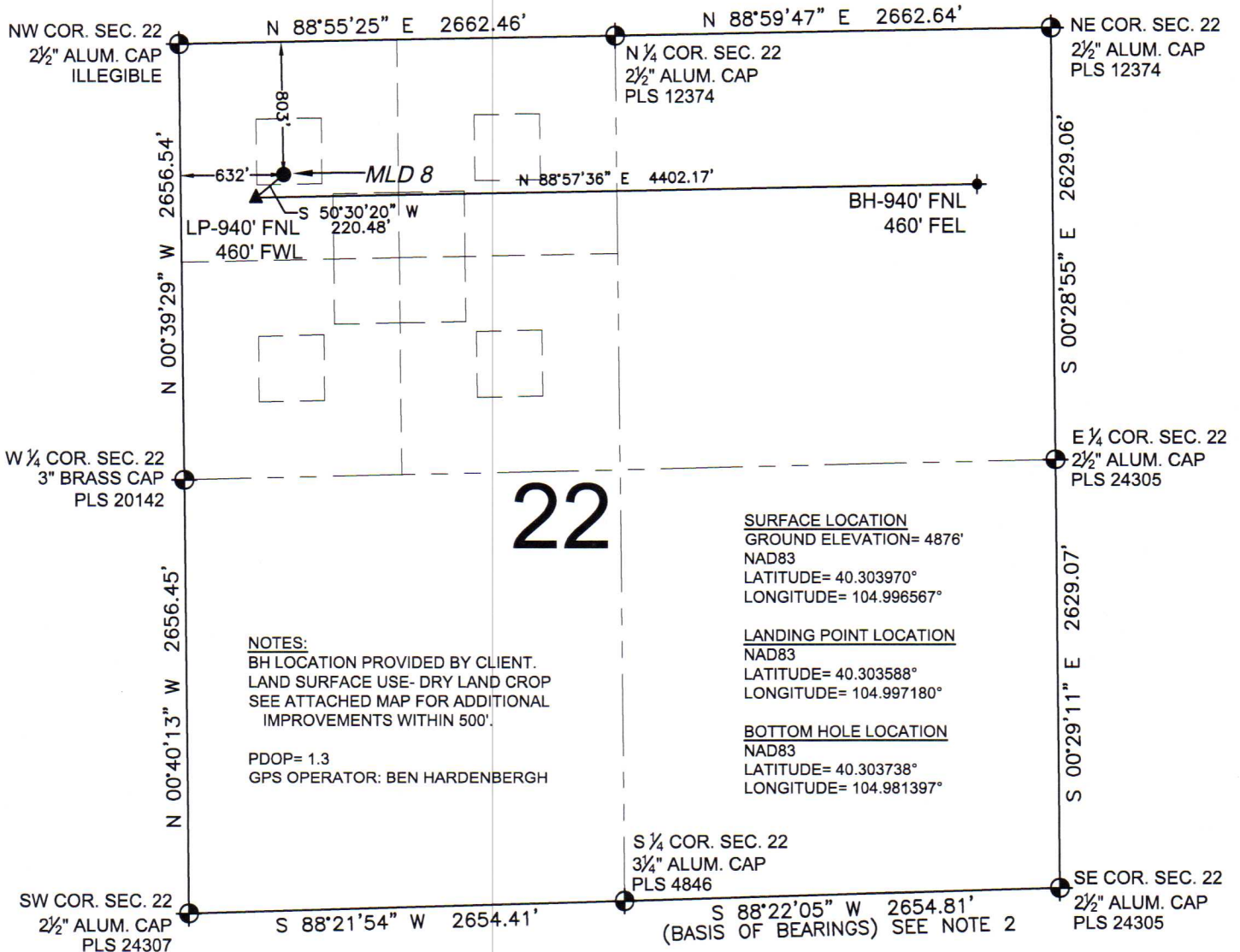
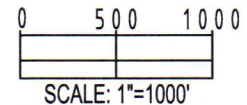


WELL LOCATION CERTIFICATE: MLD 8

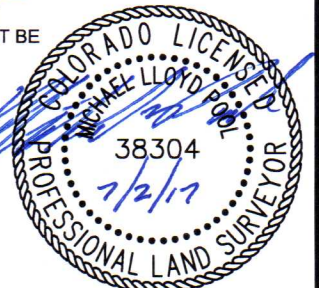
