Operator Comment: Due to location being an active remediation site (4891) and the active midstream gathering equipment, the access road needs to remain in place for access to location.

COGCC Decision: **Not Approved**

COGCC Representative: After further review the remediation #4891 has not been completed therefore the access road and groundwater monitoring wells can remain until the remediation project is completed. The cattle guard at the beginning of the access road must be maintained and stormwater and noxious weeds must be controlled. The gathering equipment must be removed and reclamation at the location must be performed. The corrective action remains excluding recontouring and reclaiming the access road and for removing the groundwater monitoring wells.
