<p>Comment: Stormwater controls have been installed in the southeastern portion of the well pad and along the northern and northwestern edges of the access road. Still, insufficient stormwater controls are installed in the southeastern diversion and southeastern well pad, as large areas of bare soil are exposed and will erode during precipitation events. Additionally, a portion of the northeastern fill slope is eroding onto the access road drainage.</p>						<p>Date: 08/11/2017</p>
<p>Corrective Action: Additional stormwater controls need to be installed in the southeastern portion of the project area where there is little vegetation and erosion is occurring, as well as the southeastern well pad diversion. Seeding of exposed soils is recommended during the fall 2017 seeding window to help stabilize eroding areas. The portion of the northeastern fill slope that is eroding needs stabilization and sediment controls in the roadside drainage where sediment is being deposited and transported.</p>
