Tinhorn /oil skim culvert will be removed, as well impacted soils. Confirmation samples will be taken from each side-wall and from the bottom of the pit, and analyzed for BTEX, TPH, pH, SAR, and EC.

Rilling at the PW pit berm will be filled in and graded, and then a ditch and berm system will be installed to prevent runoff from entering the pit. Salt kill area will be ripped, treated with soil ammendment if necessary, and seeded with salt resistant vegetation.
