Comment: Project area is surrounded by pinion juniper woodland. A 2014 reclamation inspection had a corrective action to submit a reclamation plan to revegetate the interim reclamation areas. This was not received. However, it appears that seeding was conducted within the interim reclamation areas, and although weedy, revegetation is progressing. This will need to be monitored and if the cover of desirable vegetation is not increasing, additional reclamation efforts will be needed.
