Comment: On 7/12/2017, I was informed of a complaint received by the COGCC concerning odor occurring on 7/11/2017 in the area south of the Crestone Peak Resources, Waste Connection drilling location.

On 7/12/2017, I performed an inspection of the drilling location indicated by the complainant and observed Ensign drilling rig 153 performing drilling operation for Crestone Peak Resources. I reviewed location records which did not show any abnormal drilling conditions at the time of the complaints. Records indicated that at 06:30 PM the rig had stopped circulating mud and began tripping pipe. I advised Crestone Company personnel that COGCC had received complaints of odors off location. At the time of inspection no odors were detected.

All information reviewed and site inspection information were submitted to the complaint specialist for further review.
