Comment: **FIR Doc. # 682401216 noted large portions had no native, perennial vegetative growth, and that further reclamation activities may be needed to comply with Rule 1004. Appears the location is in the same vegetative condition, approximately one year later. Bare ground with little to no perennial vegetative growth that is reflective of reference areas. List B CO Noxious weed, Musk thistle, observed flowering at the location. Please refer to the attached inspection photos.**

Corrective Action:	Perform reclamation per 1000 series reclamation rules, and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed.
