Comment:

Reclamation rules require reclamation activities to be conducted within three months of plugging on cropland. Well was plugged 10/31/2013. The well location meets Rule 1004 standards; however, the battery location does not meet reclamation requirements. Gravel remains throughout the location and access roads which have not been re-contoured or re-graded; compaction alleviation has not been performed based on the field inspector failing to penetrate more than an inch into the soil with a shovel; weedy, annual vegetation was observed which includes but not limited to cheatgrass and kochia. A List B CO Noxious weed, Musk thistle, was observed and flowering at the location. Please refer to the attached inspection photos for more details.

Corrective Action:

Since the spring seeding window has passed, revegetation activities shall be complete no later than 11/15/17. The following shall be performed by 8/15/17: Remove gravel from location and access road, perform compaction alleviation, recontour/re-grade access road, perform compaction alleviation, and manage noxious weeds. Ensure temporary stabilization controls are in place until revegetation activities can occur later in the Fall. See COGCC comments for additional corrective actions regarding revegetation.

Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS.
