During drilling operations, a buy back meter will be moved to the RU 44-7 pad and the proposed oil line may be used to supply fuel gas for the rig. If the oil line cannot be used, then a 2" temporary surface line will be installed from the RU 44-7 pad to the RU 31-17 pad following the proposed road/ROW.

Completions will frac from the RU 44-7 pad. 3-4.5" temporary surface frac lines (4747' ea.) will be installed from the RU 44-7 pad to the RU 31-17 pad following proposed roads or ROWs.

On pad, 1-2" dump line to the blowdown tank and 18-2" flowlines will be installed.

Summit will install a 12" gas line from the RU 44-7 pad to the RU 31-17 pad following the proposed access road to the RU 31-17 pad. In the same trench with Summit's gas line, a 2" condensate line and a 4" produce water line (4747' ea.) will be installed to move water and condensate to the RU 42-7 tank battery. The 6" produced water line and 2" condensate line will tie into existing infrastructure near the RU 44-7 pad.
