COGCC Environmental Inspection of spill at Tank Battery Facility: Binder 9, 10, 15, 16, 20-28. Tank battery equipment and tanks were not inspected due to the remediation excavation in progress.

Comment: COGCC inspection of spill at separator reported by Operator via email on 7/17/2017. Excavation was in process with hauling of impacted material from location. Impacts extend to bedrock and ground water. Impacts to the north and west walls of excavation were present. COGCC could not view the south wall. Pictures from COGCC inspection are attached. Operator is to proceed with spill reporting per Rule 906, and remediation of ground water with a Form 27 Site Investigation and Remediation Workplan per Rules 909 and 910.
