Venessa,

I have reviewed the referenced Form 2A Oil & Gas Location Assessment and have the following comments.

1) You have included an Operator comment stating Floodplain and Wetlands permits have been submitted for this location. Who were these permits submitted to and what is their current status? [The floodplain permit was approved by Weld County Department of Planning Services and the Wetlands permit approved by Corps of Engineers.](#)

2) You have included a Traffic Plan BMP stating that a traffic plan will be coordinated if required by the local government. Will you revise this BMP to indicate whether the local government requires a traffic plan or not. [A traffic plan has been deemed unnecessary by the local government.](#)

- 3) You have included a Berm Construction BMP stating a design drawing for the proposed flow through fencing is attached. However, I did not see this design drawing included in the attachments. Will you provide it to me and I will add it to this Form 2A. [Attached](#).
- 4) You have included a Construction BMP indicating the temporary water tanks will employ the same berm construction, floodplain anchoring, and emission control measures as the permanent tanks. Thank you for including this. However, no floodplain anchoring BMP was included on this 2A. Will you provide me with a floodplain anchoring BMP that demonstrates PDC Energy's compliance with Rule 603.h.(2)B?

PDC will anchor all equipment at drilling and production sites in geological hazard and floodplain areas to the extent necessary to resist flotation, collapse, lateral movement, or subsidence.
