Required COGCC 1000 series reclamation activities such as (but not limited to) compaction alleviation, re-contouring, re-grading and revegetation of the access roads, well and battery locations have not yet occurred. Reclamation rule 1004.a requires that all reclamation work shall be completed within twelve (12) months on non-crop land after plugging a well or final closure of associated production facilities. Reclamation activities will need to be conducted by 06/20/2018.
