#### COMMENTS:

Murfin will construct a reserve pit that is 18' wide X 65' Long X 10' Deep on one end and 5' Deep on other end on location for the storage of water-based bentonitic drilling fluids and drill cuttings during drilling operations. The fluids will be sucked off daily and the solids left for drying and testing for 910 compliance prior to backfill. Solids will be ripped or tilled to prevent clay barrier. Samples of fluids will be kept and checked prior to land application. Land application will be done according to Rule 907.d(3)B. Record will be kept of the source, the volume, and the location where the land application of the water-based bentonitic fluid occurred. Murfin will collect at least four soil samples at the land application site prior to applying drilling fluids. Samples will be analyzed for at least arsenic to provide background levels.
