Comment:

Inspection Doc. #682501136 performed transect and indicated location was only 50% of the reference, and required operator to perform additional reclamation. It is unclear if reclamation activities have been conducted, however after a fairly wet 2017, vegetation does appear to be progressing to reclamation standards. Continue to monitor and manage location. If location does not continue to progress to reclamation requirements, perform additional work as needed. Once location has achieved final reclamation standards, submit form 4 and a transect will be conducted to re-evaluate compliance.
