Comment: Reclamation Rule 1004.a requires all Equipment, Associated Facilities to be removed within three months of plugging the Well. All work should have been conducted by 1/19/2005. Location does not meet Reclamation Regulations. Vegetation does not meet the 80% of reference area requirements. Refer to Photos attached for identity & Position of Risers.

Corrective Action:

Date **09/01/2017**

Comply with reclamation rules to remove all equipment by 9/1/2017. Perform reclamation of Location in accordance with COGCC 1000 series requirements, establishing vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage site until Final Reclamation passes. Revegetation activities shall be complete no later than 11/30/2017. Refer to Photos attached for identity & Position of Risers.
