OPERATOR COMMENT

As proposed, a subsurface investigation was attempted on July 5, 2017. During borehole clearance activities conducted with a hand auger (prior to drilling), saturated soils and groundwater were encountered across the site at one to two feet below ground surface (bgs). Cropland irrigation and recent precipitation appear to have created an elevated groundwater table and zone of saturation. The operator proposes to postpone the subsurface investigation until late-fall/early winter 2017, or to when groundwater elevation returns to natural levels (approximately twelve feet bgs) encountered during initial subsurface investigation activities.
