Describe what is known about the spill/release event (what happened -- including how it was stopped, contained, and recovered):

148 bbls of produced water and 25 bbls of crude oil was released within containment and 150 bbls of produced water and 10 gallons of crude oil was released outside of containment from a tank on location at the Critter Creek 19-23H. Once the leak was discovered the well was isolated effectively stopping the leak. The cause of the spill was determined to be due to increase flow in the wellbore caused by frac operations on an offset well. A crew was dispatched to location and 265 bbls of produced water and 23 bbls of crude oil were recovered. The impacted soil outside of containment has been remediated and will be hauled from location. The impacted soil within containment is being evaluated and the appropriate remediation will occur once extent of the contamination is known.
