Wexpro stated that this well is no longer viable and proposed to construct an approximate 150,000 bbl evaporation pit at this Location. Currently infrastructure is in place which includes six 400 bbl tanks for slop oil (condensate) separation and produced water. All tanks are in a lined steel bermed secondary containment.</li> <li>• Wexpro representatives stated that when this Location is active, typically 3-4 trucks per day would services this Facility.</li> <li>• BLM had concerns regarding the sage grouse at the proposed Location and proposed other possible Locations (Musser 4 and 25) in Sections 4 and 5, T11N, R97W.</li> </ul>	fischera	08/07/2017
