


PAD CROSS SECTION DETAIL







Access Road Map





RIG LAYOUT





PROPOSED RECLAMATION DRAWING





EXISTING WELL PAD / PRODUCTION EQUIPMENT DIAGRAM




DENOTES EXISTING WELL HEAD

- LEGAL DESCRIPTION -

A pipeline easement being forty feet (40') wide located in the SW/4 NE/4 of Section 9, Township 32 North, Range 5 West, N.M.P.M., Archuleta County, Colorado. Said easement lying twenty feet (20') on each side of the following described centerline:

Beginning at the end of an existing gas flowline, whence the Northeast corner of said Section 9, being a 3-1/4" dia. BLM Brass Cap, bears N38°35'54"E a distance of 2358.32 feet.

Thence N09°22'55"E a distance of 20.03 feet, ending at Red Willow Production Company: North Carracas 32-5 #9C-3 well flag whence said Northeast corner of Section 9 bears N38°50'16"E a distance of 2340.86 feet.

Described easement being 20.03 feet in length & containing 0.02 acres, more or less.

From the Intersection of State Highway 172 & State Highway 151 in Ignacio, CO. travel East on State Hwy 151 for 19.7 miles;

Go right (East) for on Archuleta County Road #500 for 2.8 miles;

Go left (East) on gravel access road for 0.2 miles to staked well location on existing West Pilot well pad.
