Completions will frac from the PA 23-25 Frac Pad. 3-4.5" steel temporary surface frac lines (5206') will be installed from the PA 23-26 pad to the PA 23-25 Frac Pad following existing two-tracks. Frac lines will run cross country down the hill side about ¼ mile north east of the PA 23-26 pad. Water will be supplied to the frac pad through 2-10" temporary surface water supply lines to be installed from the existing 10" water line to the frac pad.

A new 8" gas pipe line (approx. 3769') and 4" flexpipe water line (approx. 3769') will be installed following the existing access road and pipe line ROWs. Gas and water lines will tie into existing infrastructure north of the existing East PA Tank Battery. 2-2" flexpipe oil lines (approx. 511') will be installed from units to the proposed tank battery located south of the PA 23-26 pad along the existing access road.
