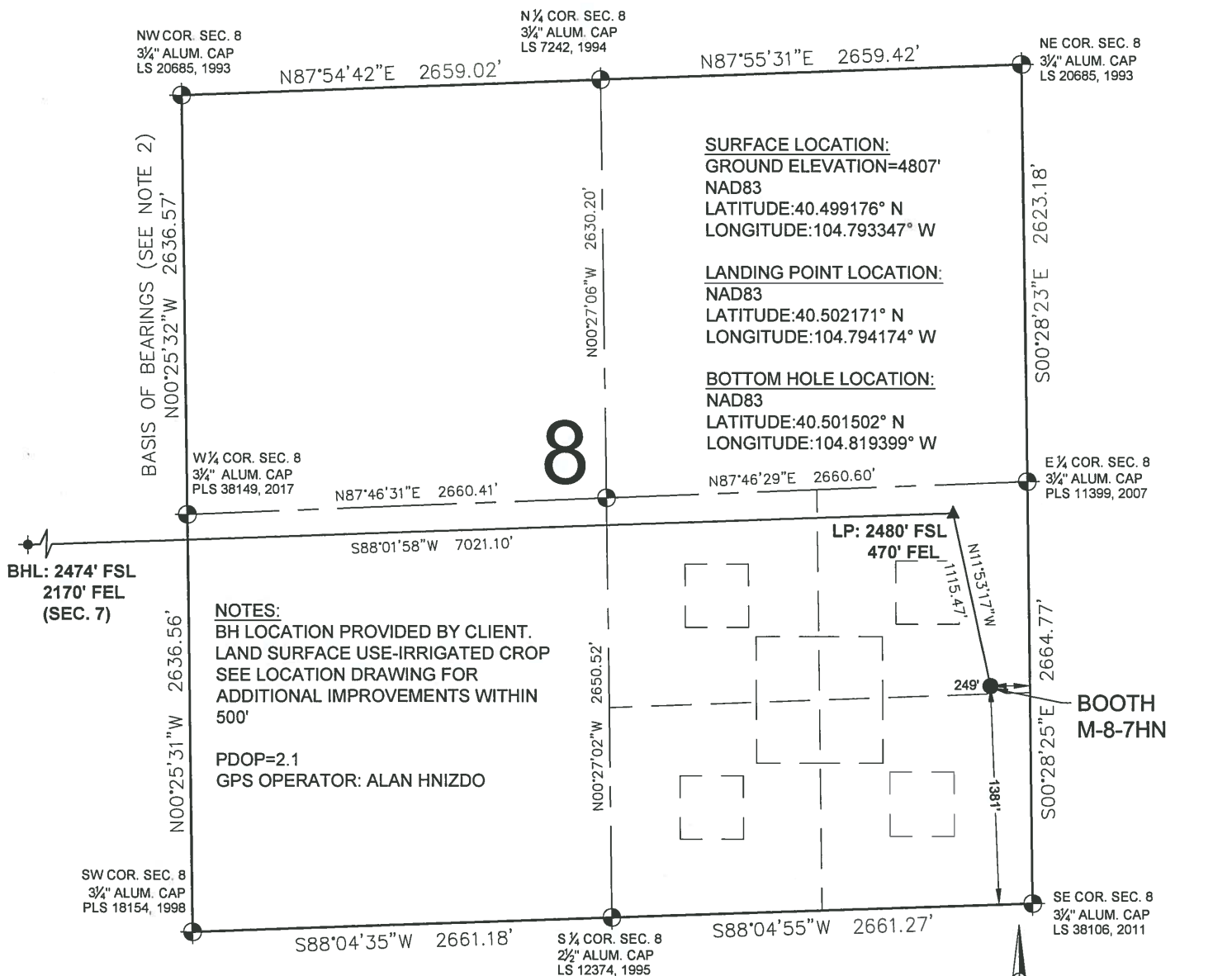


BOOTH M-8-7HN WELL LOCATION CERTIFICATE

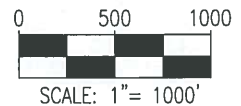
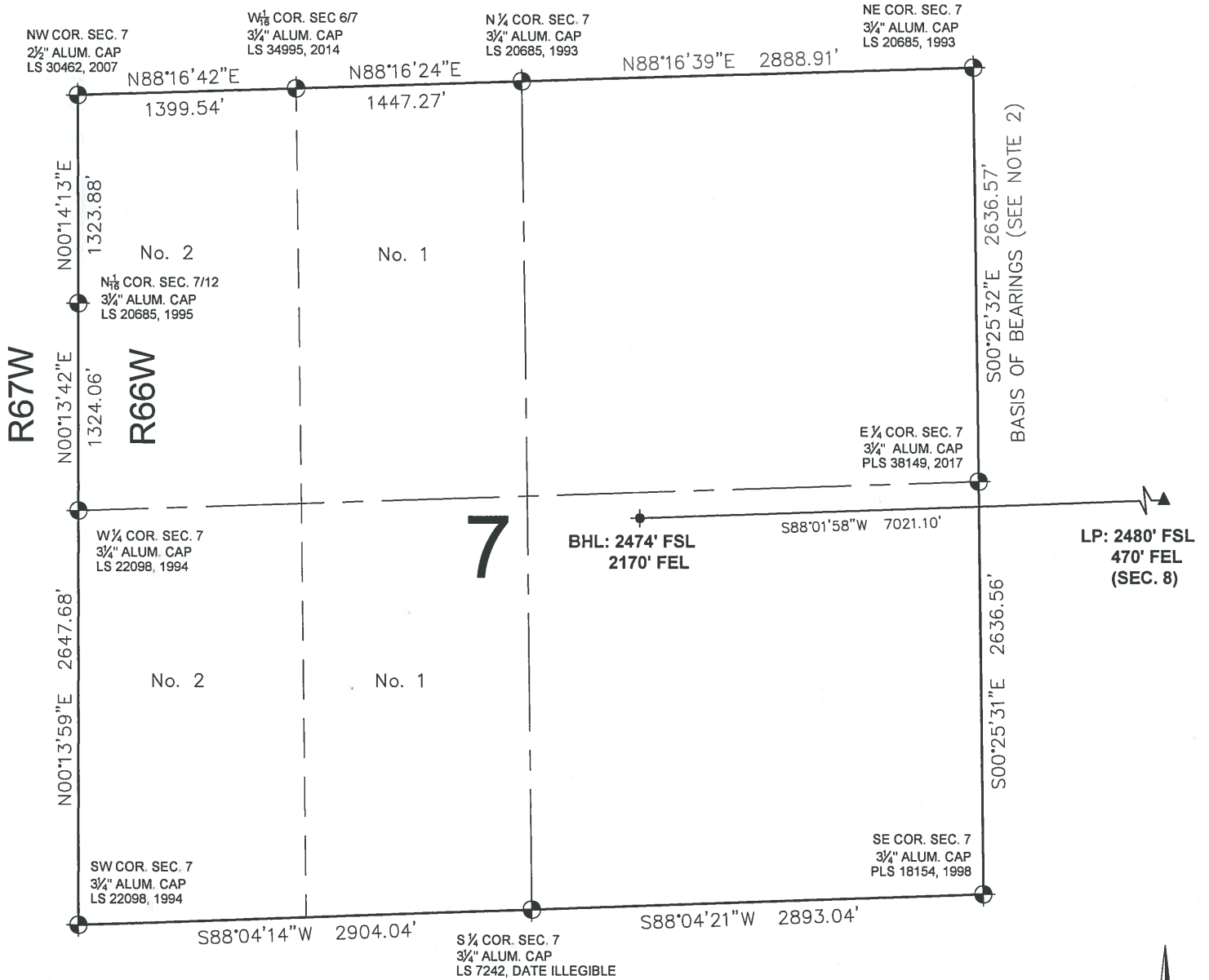
