Comment: Inspection doc. #682502088 required operator to perform reclamation on the access road and location, and to remove pipe riser equipment. FIRR doc. #401296905 indicated that "reclamation activities have been performed". Based on on the ground observations, the battery and well location appears to have had additional reclamation work conducted. However, pipe riser equipment, and access road has not been reclaimed in accordance to COGCC 1000 series reclamation requirements. Original CA and CA dates remain in place.

Corrective Action:	Remove pipe riser equipment in accordance to COGCC reclamation rule 1004.a. Perform reclamation: remove equipment (cattle guard/gate) from access road, remove gravel from access road. Perform compaction alleviation, recontour, regrade access road. Manage weeds and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. Revegetation activities shall be complete no later than 6/30/2017	Date	06/30/2017
