Comment: Reclamation rules require reclamation activities to be conducted within three months of plugging on cropland. Well was plugged 1/18/2013. Location ID 327207 with API 123-14314 does not meet Rule 1004 standards as the disturbance of the location is evident and mainly consist of weedy, annual vegetation. The disturbance location is not reflective of reference area vegetation that is comprised of Russian wildrye (Elymus junceus). Subsidence was observed at the northern well location. See attached inspection photos for more details.

Corrective Action:	Perform reclamation in accordance to COGCC 1000 series reclamation rules. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Use a seed mixture requested by the surface owner or a seed mixture provided by the county Natural Resources Conservation Service. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. Collaborate with the landowner to determine mitigating measures that will allow reclamation work to be conducted in such a manner as to not interfere with agricultural activities or crop production. Reclamation activities shall be completed by 11/15/17.	Date	11/15/2017
