Comment: There is gravel that remains at the former tank battery site. The soils appear to be compacted along the access road, location, and tank battery site. The desirable vegetation has not established and there is predominately undesirable weed growth (Kochia sp.). Upon removal of unused equipment and debris from the tank battery site, reclamation will need to be performed and completed by the corrective action date. See Attached Photos

Corrective Action:	Comply with the 1004 Reclamation Rules. Remove all gravel and debris that remains. Decompect soils by cross ripping to a minimum depth of 18 inches. Reseed areas of disturbance and stabilize the soils with a certified weed free mulch or equivalent method until vegetation establishes.	Date	11/30/2017

Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS.
