Comment	Cuttings have been stockpiled on a parcel owned by Kinetic Energy Services LLC in the SW 1/4 SE 1/4 Section 2 Township 5 North Range 67 West, Weld County. Kinetic personnel informed COGCC that cuttings were generated by Cub Creek Energy (Xtreme 18 rig). Xtreme 18 is currently drilling the Litzenberger Pad (Location 444819). Form 2A for the Litzenberger Pad states that all drilling fluid and cuttings will be transported offsite for commercial disposal. No Form 4 Sundry Notice for the application of drill cuttings has been submitted for Director approval per the COGCC Drill Cuttings Management Policy dated September 15, 2014 (http://cogcc.state.co.us/documents/reg/Policies/Final_Cuttings_Management_Policy_9_15_14_Rev_0.pdf).			
Corrective Action	Operator is directed to: 1. Submit a Form 4 Sundry Notice of the beneficial reuse of E&P Waste for the Land Application Site. The Waste Management Plan will need to be revised with appropriate timing for the incorporation of drill cuttings per the COGCC Drill cuttings Policy. Use Facility ID #451969 when submitting the Waste Management Plan. 2. Submit a Form 4 for each Form 2A to change the drill cuttings handling from commercial disposal to offsite land application. 3. Incorporate all stockpiled cuttings by September 30, 2017 as you have stated below. Any cuttings not incorporated by that time must be hauled to a commercial solid waste disposal facility. 4. Post-incorporation sampling is required to document compliance of the soil with Table 910-1. 5. Submit waste manifests or haul tickets/bill of lading for all E&P Waste transported from the Litzenberger Pad and for all E&P Waste subsequently removed from the Kinetic Energy property.
