Comment:

Location does not yet meet Reclamation Regulations. Vegetation cover and composition on location is insufficient and was assessed to Not be 80% of the surrounding area. One Large area, approximately 150 X 150 Ft has not revegetated; from Historical aerial imagery this appears to have been a Land Farming site for adjacent Well API# 057-06462. The Locations of the two Wells appear to have been overlapped, and areas of the Subject Well's Location used for production facilities/ Land Farming of the adjacent Well that was P&A in 2011; five years after P&A of Subject Well plugged in 2006. Noxious Weed, Canada thistle is established in areas that have revegetated. Access Road has not been reclaimed. Refer to Photos attached for detail.

Corrective Action: **Control Noxious Weeds by 9/30/2017. Reclaim Access Road and Location areas bare of vegetation ; Seeding/Reseeding as needed; Reclamation activities to be complete by 11/1/2017.**
