A small amount of Debris remains (Cable, PVC). Noxious Weeds, Canada and Russian thistle are established on Location & Access Road

Control Noxious Weeds by 10/2/2017. Reclaim Location and Access Road. Perform Final Reclamation per COGCC 1004 Rules. Reclamation Activities to be complete by November 1, 2017.
