**Nature of complaint: Odor**

**Field Inspector Actions:**

On 8/29/2017, while driving in the area of Vista Ridge when I was contacted by a complainant in the area indicating she could smell a very bad petroleum odor in the area of her residence at 1896 Alpine Dr. in Vista Ridge. I proceeded to her residence where I smelled a chemical odor which appeared to be coming from the drilling rig at the Pratt location. The odor detected appeared to be travelling with the light winds which appeared to be coming out of the NW. The drilling rig is located NW of the complainants residence.

After smelling the odors I went to the Pratt location where I did verify the odors detected off location appeared to be the odors coming from the drilling rig at the time of the inspection the odors on the location did not appear to be strong and while on location I did detect odors coming from the dump located to the east of the Pratt site.

I advised Crestone I had detected odors off location but at the time of inspection of the location I did not believe Crestone should increase their odor mitigation as the odors on location did not appear to be strong. Crestone representative Buddy Burke indicated to me Crestone had just returned to regular drilling activity at approx. the time the complainant had made her complaint.

After completing site inspection I contacted CDPHE who were in the area has I had contacted them about the odors I had smelled earlier. We went back into the area where I smelled the odors ealier and again detected an odor in the area. CDPHE staff member Alicia Frazier detected the odors and was able to detect the presence of diesel fuel in the air with her PPBRae 3000 handheld PID sampling device. CDPHE report was attached to the inspection doc# 674200209.

All information reviewed and site inspection information were submitted to the COGCC for further review.

Corrective Action: **Odor observed by COGCC staff related to referenced oil and gas location, actions must be taken to stop the odor per Rule 805.b. Additionally, this matter has been referred to the CDPHE for possible further investigation.**
