The spacing unit is a 320-acre wellbore spacing unit for the Niobrara and Codell formations.



SEC 10: N2N2**




**JESSER 3E-10-15N WELL TO BE LOCATED 2314' FSL AND 636' FWL, SEC 3, T4N, R68W**
