The spacing unit is a 360-acre wellbore spacing unit for the Niobrara and Codell formations.

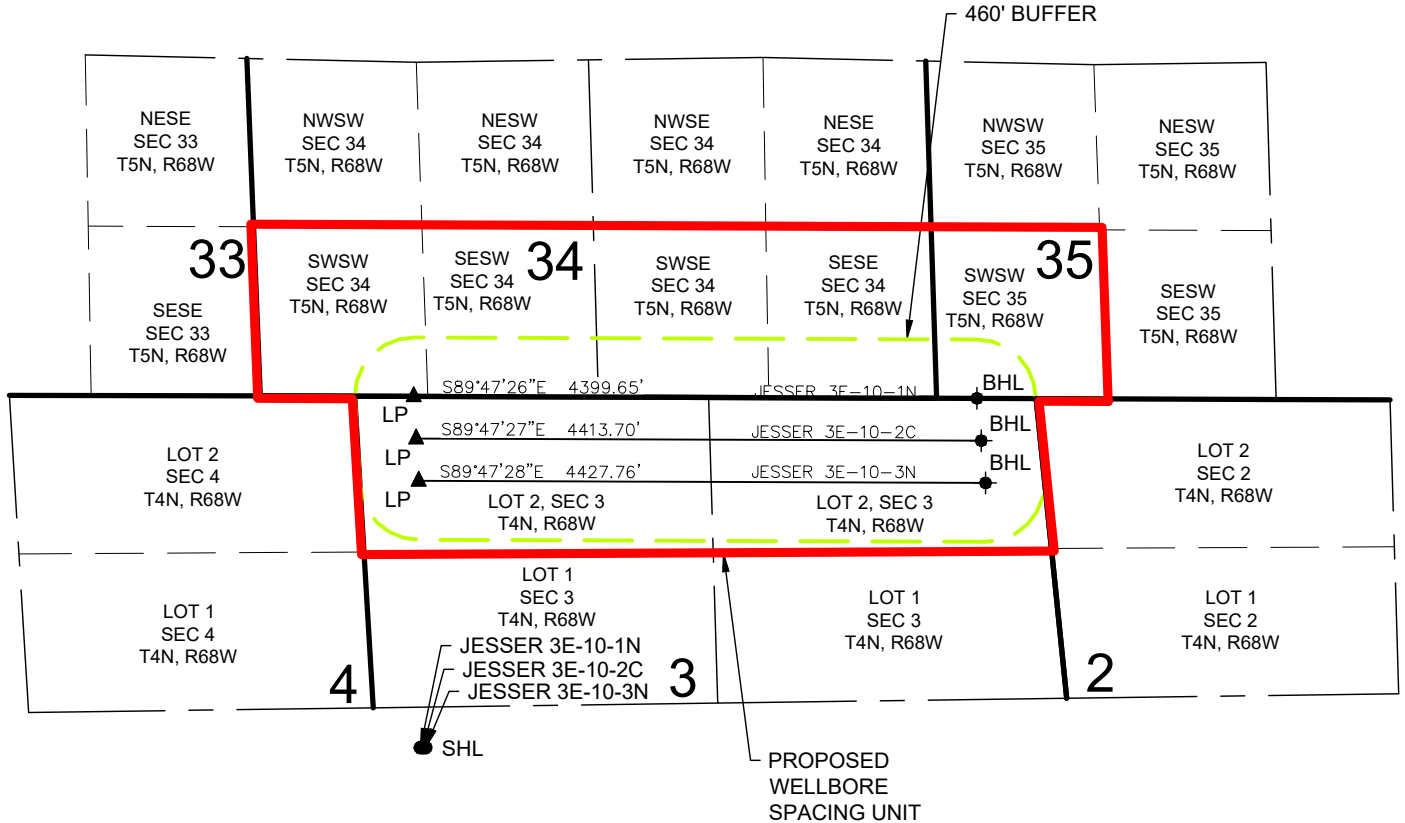
