The spacing unit is a 320-acre wellbore spacing unit for the Niobrara and Codell formations.



JESSER 3-I PAD PROPOSED 318A.a.(4)D. SPACING UNIT SEC 3: S2




JESSER 3E-10-11N WELL TO BE LOCATED 2314' FSL AND 556' FWL, SEC 3, T4N, R68W
