Bayswater Exploration & Production, LLC (Bayswater) is planning to drill 12 horizontal wells on the above referenced pad as follows:

The surface locations of the above referenced proposed wells have been staked outside of the Colorado Oil & Gas Conservation Commission (COGCC) Rule 318A.a. Greater Wattenberg Area Drilling Window and are being permitted as exception locations. Bayswater's northwestern most proposed well is located approximately 155 feet northeast of the NWNW Drilling Window. These wells are being proposed outside of the Drilling Window due to an agreed upon location in the Surface Damage Agreement with the surface owner. Bayswater has obtained written permission from the surface owner by way of signed waiver.

Under COGCC Rule 318A.c. any new twinning well is to be located within fifty (50) feet of an existing well. The surface well locations of the wells referenced above have been staked between 333 and 429 feet from the existing Reeman 11-5 well and are being permitted as exception locations. Bayswater has obtained permission by way of a signed waiver.
