Comment: Approximately 200 musk thistle are growing along the access road to the well pad. It appears many have been treated, but many surviving individuals remain and most are flowering or dispersing seed.

Corrective Action: Flowering and seeding individuals need to be removed (and properly disposed of) to prevent further seed dispersal, and additional treatments will be needed in 2018 (before flowering).
